



Online Waiver and Release of Liability

IN CONSIDERATION of the acceptance of my online registration by Circle T Amusements (hereinafter referred to as “Oswego Speedway”), the issuance of any license or credential, and my being permitted to enter upon, participate in, or be present on the speedway or raceway premises for any Oswego Speedway event or any Oswego Speedway-sanctioned event, I, on behalf of myself, my heirs, next of kin, personal representatives, and assigns, hereby **FOREVER RELEASE, REMISE, DISCHARGE, HOLD HARMLESS, AND INDEMNIFY** Oswego Speedway; all promoters representing or presenting races or other events at or under Oswego Speedway sanction; the owners and lessees of premises on which such events are presented or sanctioned; all participants; the owners, sponsors, and manufacturers of racing equipment used in Oswego Speedway events or sanctioned events; and the officers, directors, agents, employees, officials, members, and servants of all of the foregoing (collectively, the “Released Parties”), from any and all liability, claims, demands, actions, or causes of action whatsoever, including claims arising from the negligence of any of the Released Parties, which may accrue to me or my heirs, next of kin, or personal representatives, for any loss, damage, injury, or death to my person or property while in, about, or en route into or out of any premises where Oswego Speedway events are presented or sanctioned.

I HEREBY CERTIFY AND ACKNOWLEDGE that any license, credential, or permission granted as a result of this registration is granted solely for the purpose of enabling my participation in motorsports-related activities, including but not limited to competition, testing, practice, or other activities in furtherance of Oswego Speedway events. I further acknowledge that my presence in, about, or en route into or out of any Oswego Speedway premises is voluntary and in furtherance of such events, and that motorsports activities involve inherent and significant risks, including serious injury or death.

BY COMPLETING THIS ONLINE REGISTRATION, I hereby irrevocably grant and assign to Oswego Speedway all rights to use my name, likeness, image, voice, and the image of any vehicle associated with my participation, whether portrayed in still photographs, motion pictures, video, drawings, or other media, for any lawful purpose, including promotional, commercial, or archival uses, without compensation.

I FURTHER CERTIFY AND ACKNOWLEDGE that I have been provided access to and have had the opportunity to review the “2026 Online Oswego Speedway Official Rule Book,” which governs participation in Oswego Speedway events for the 2026 season, and that I agree to comply with and be bound by all rules, regulations, and conditions set forth therein.
